Clerk's Report

Annual Meeting March 1, 2015

The 288th Annual meeting of the Groveland Congregational Church was called to order at 11:32 a.m. by the moderator, Robert Lay.

Sixty-one members present.

Article 1. To view and receive the 2014 reports of the Pastor, Officers, Boards, Committees and Organizations of the church.

Motion to accept was made by Doug Latham and seconded by John Statom. Bob Kent took the floor to comment on the overall condition of the church. First, noting the Clerk's report and the numbers that make up our membership. Next, he gave accolades to the Thrift Shop and the Missions Committee, asking for a standing ovation which he got immediately. Lastly he brought our attention to the Buildings and Grounds Committee and all the work they have done.

Linda Prescott wished to make a correction to the Clerk's Report. She was Vice Chair of the Board of Trustees last year.

Motion accepted.

Article 2. To see if the church will vote to accept the proposed budget for 2015 current expenses as presented by the Board of Trustees, and to transfer General Fund and cash balance of 2014 to the 2015 General Fund or to take any action thereon.

Motion to accept was made by Deb Stephenson and seconded by Betsy Latham.

Kevin Sullivan and Linda Prescott from the Board of Trustees presented the budget for 2015 with the \$13,000 shortfall in income that they had to work around. Deb Stephenson requested that the position of Director of Christian Education be returned to the budget as soon as it is feasible. She was assured that this would be done.

Motion accepted.

Article 3. To hear and act on the report of the Nominating Committee.

Motion to accept was made by Jen Petersen and seconded by Betsy Latham.

Several members spoke thanking those who are leaving their committees for their work as well as thanking the new members for taking on their new positions.

So voted.

At this time the Moderator swore in the Clerk and the Clerk then swore in the Treasurer, the Financial Secretary and the Board of Trustees. Don Dickison was absent so the Clerk will swear him in as soon as possible.

Article 4. To see if the church will vote to renew the standing policy that the church and the minister enter into a voluntary agreement to withhold income taxes and Social Security for the minister according to IRS rule [IRC Sec. 3402 (i); Reg. Sec. 31.340(a)-3; 31.3402(p)-1].

Motion to accept made by Betsy Latham and seconded by Sandy Daniels.

Motion carried.

Article 5. To see if the church will continue to sponsor Boy Scout Troop 87, and Cub Scout Pack 113, during 2015.

Motion to accept was made by Sue Harnden and seconded by John Statom.

Motion accepted.

Article 6. To act on any additional business that may properly come before the church at this time.

Bob Kent made the suggestion that we as individuals consider making our charitable contributions through missions projects as their giving is researched well and does so much good both locally and outreach to the country and the world.

The Rev. Dallaire reminded people that boards and committees will be meeting directly after this meeting to organize.

Bob Lay told people that the Planning Committee would be soliciting their help in developing a long term plan for our church. The more people who participate the better that plan will be.

Motion to adjourn was made at 12:05 p.m.

Special Meeting

November 8, 2015

The meeting was called to order by Bob Lay, Moderator at 11:12 a.m.

There were 87 members present.

Sandy Keene led us in an opening prayer.

Article 1: To see if the church will vote to accept the resignation of The Reverend Lance Dallaire as of December 31, 2015 and provide him with a retirement package of health and dental insurance for January 1 through June 30, 2016. Motion was made and **seconded** for favorable action.

During the year the Deacons provided support at every worship service with the reading of announcements, opening the service, welcoming and supporting attendees, and cleaning and securing the sanctuary following the service. We also prepared and served communion on the first Sunday each month, coordinated ushers for each service, and supported the pastor during baptisms, confirmation, new member welcome service, and other special events. We ensured worship service and communion supplies as well as Care Notes were available. We rotated the sending out of many cards to members during times of illness, bereavement, and other noteworthy events in their lives.

With the resignation of Pastor Lance Dallaire the end of 2015, we took on the responsibility to schedule Supply Pastors Patricia Long, Alice Erickson, and Rona Tyndall to ensure we continue spiritual leadership and inspiration each Sunday during our worship service until we acquire an Interim Pastor. We work with each of them to coordinate the service and to address congregational issues when they arise. We scheduled Rev. Wendy Vander Hart from the Mass. Conference of the UCC to preach about the pastoral transition process on December 6 and to conduct a meeting with GCC members following church regarding that process. We worked with the other two boards to develop a letter to all members explaining the transition process, and we worked with them to develop a Local Church Profile for use in acquiring an Interim Pastor. We are now scheduling visits and contacts for those members previously receiving regular pastoral care.

Again this year we coordinated two "Bring a Friend to Church" Sundays to provide our members an opportunity to invite their friends to join us for worship in order to introduce the Groveland Congregational Church to others in our community. We coordinated our annual Homecoming Lunch in September and a special Christmas Lunch in December for these Sundays to promote fellowship after services.

Other activities that we participated in this year were:

- Supported the Board of Christian Education by providing communion to the youth of our church once each month during Children's Chapel.
- Supported Pastor Lance for several funerals when assistance was needed.
- Provided "Deacon Details" for each month's Bell to inform all members of Deacon activities.
- Developed a contingency worship service in the event the pastor couldn't lead the service on a given Sunday.
- Identified members we hadn't seen in church recently and contacted them to check in with them and to let them know that we missed them.
- Sent invitations to our Homecoming service to members we hadn't seen recently.
- Collaborated with the Stewardship Committee for the Pony Express Campaign to acquire pledges for 2016.
- Developed and consolidated a Time and Talent Sheet to allow members to volunteer for various church activities.

We wish to thank all of you who helped us in the roles of lay reader, usher, serving communion, Deacon-in-Front, Deacon-in-Back, and mentoring new members. Specifically, we'd also like to thank the following members for their valuable support:

Missions Committee

With the continued support of the Groveland Congregational Church family, our church's mission activities have continued to flourish and also to grow. Your support, both monetary, and in the form of time, enthusiasm and ideas, have kept the focus on addressing need, hunger and homelessness in our community and the world.

The proceeds of the Thrift Shop supply the majority of the funds that the Missions Committee is able to donate during the year. This year, a whopping \$24,241 was raised there! As a result, the committee was able to choose the organizations that we felt were most deserving of funding, in keeping with the congregation's view to address those needs: Salvation Army, Church World Services, Bethany Friends, Anchor of Hope, Emmaus Inc., Bread for the World, Lazarus House, Project Bread, Elder Services of the Merrimac Valley, Groveland Council on Aging, Joyful Ladle, Boston Rescue Mission, Lowell Transitional Living Center, Habitat for Humanity, Open Hand Pantry, Our Neighbor's Table, and UCC Nepal Earthquake Relief. The church also has 3 pantries/shelters that we support quarterly: Emmaus House, Pettengill House and the Joyful Ladle.

This would not be possible without the effort of the Thrift Shop volunteers, who work tirelessly every week to keep this vital ministry going and we thank them for their dedication: Sandy Daniels, Barbara Herrick, Nancy Mello, Ruth Gilford, Joan Parah, Gloria Kemper, Dona Labrecque, Jay Collins, Michael Hogg and Bill Rogers.

A new mission activity started this year, the weekly Panera Bread pick-up, has delivered baked goods to shelters, food pantries and senior citizens. A thank-you note from Emmaus House thanked GCC for helping extend their mission even further with this additional food source.

Church family supplied and prepared the monthly Emmaus and Mitch's Place meals, delivering a hot meal to those in need and our food pantry collection supported various area soup kitchens and organizations such as Pettengill House, Open hand pantry, and Groveland and West Newbury COA's.

Teams in Deed conducted Taizé services and held folks in prayer, provided rides to church and picked up and delivered items, cooked, baked and did jobs around the church.

The traditional Spring Roast Beef Dinner and Fashion Show provided a night of fellowship and entertainment, raising over \$700 for the general budget. The May Blind Guild luncheon was provided by past Missions Committee members, with entertainment provided by the Pentucket Jazz ensemble.

The December Adopt-A-Family program provided 50 gifts for 10 DCF children who otherwise may have had no gifts to open on Christmas morning.

Independent of the Missions committee, it is worth noting 2 projects that have sprung forth in the spirit of missions at the church and these are the monthly Second Saturday Lunch, started this year and the War, West Virginia school project. These 2 projects have involved a number of people in the church in varied ways, and demonstrates how we can, collectively, make a difference in the world by showing concern for all God's people.

This year, Groveland Congregational supported the 5 UCC special missions offerings: One Great Hour of Sharing, Strengthen the Church, Neighbors in Need, the Christmas Fund for Veterans of the Cross and Basic Support, through direct donations from the congregation and added monies from the missions budget. This identifies us as a '5 for 5' church.

Lastly, the Missions Committee is slowly working to identify how to most appropriately use the money received by 1st Congregational Church, Haverhill, and designated by the congregation for missions work. We will keep the congregation informed as progress is made.

Music Committee

We in this church are so fortunate to have such capable, dedicated leaders and choir members who bring to every Sunday Service praise and honor to God – filling our sanctuary and our hearts with beautiful music. The music ministry at G.C.C. is strong and continues to be strong!

The choir's commitment to presenting the word of God through music is very visible as they sing most Sundays September to June, as well as the Christmas Eve 11pm candlelight service. They have weekly rehearsals on Wednesday evenings.

The Senior Choir, under the direction of Kathleen Tucker Gustafson, continues it's outreach to sing to church members who are residents in area nursing homes and other residencies.

The Chime Choir prepared and presented music throughout the year that also included Easter Sunday and the Christmas Eve Family Service. The Chime Choir had 7 faithfully consistent ringers who rehearsed weekly at 8:30 am on Sunday mornings. In June, the original 2 octaves of chimes, purchased in memory of Terry Cummings, was shipped to the Suzuki Music Plant in California for refurbishment. Gretchen Dallaire, the Chime Choir Director, who retired at the end of 2015 tremendously enjoyed her years as director and will cherish fond memories of the many musical times together.

In May Justin Turner, Youth Choir Director resigned due to his commitment to higher education and schedule. The music committee then formed a job description that was sent to area music schools and colleges, private music teachers and public schools regarding the position. We are happy to report to the G.C.C. thru this process that Bonnie Surowiec was unanimously chosen to lead our Youth Choir with the support of this committee. The Youth Choir under the direction of Bonnie is small but a talented group of young people. The youth sing on a monthly basis as well as Christmas Eve and The Family Service.

June 1 brought an end to the choir year with an appreciation breakfast for the Senior and Chime choirs put on by Kathleen Tucker Gustafson, Gretchen Dallaire and Linda Paulet with donations from the congregation in thanks for their commitment throughout the year.

On September 28, during the regular Sunday morning service, all the choirs were dedicated for the new choir season.

On November 25, many members of our Senior Choir joined with voices from other area churches in an ecumenical Thanksgiving service held at the First Congregational Church of Georgetown. It was a wonderful opportunity for the choirs of many local churches to gather to sing in thanksgiving.

In late summer, Linda and Kathleen decided to program the cantata, The Winter Rose, first performed here in 2005. We recruited additional choir members from within and outside of the congregation, and Kathleen recruited instrumental players from the church, the high school and the community to accompany. The youth choir also participated. Beginning in September, the choir spent part of every rehearsal practicing the music, with sectional rehearsals being held as needed. There were two rehearsals held with the orchestra prior to presenting the cantata during the worship service on Sunday, December 20th. It was a joyous occasion, with over 300 people in attendance. We are grateful to all who made the musical presentation possible: to the youth choir and their director, Bonnie Surowiec, to Anthony Beatrice, Pentucket high school band director, who sent us three high school students one college student and also lent us all of the percussion instruments, to our narrator, Ron Mertens, flower arranger, Priscilla Styer and flower presenter, Kristie Haupt, and to all of the choir members who put in lots of extra time to learn the music.

The members of our choirs continue to bless our worship services with their talents.

We are always looking for new members in all of our choirs. Children and adult lives change so there is always a place FOR YOU! Come to join us and raise your voice in song or ring the chimes. All our choirs are warm and welcoming and looking forward to having you join us.

Flower Coordinator

Thirteen of these plants were delivered to Penacook Place by Bob Nelson and the other four were delivered to a nursing home In Andover by Barbara McGovern.

Baptismal Roses- A single white rose is given by our church family in honor of a child being baptized. Six flowers were given in Christian love this year.

Easter and Christmas plants are purchased directly through the grower, Newton's Greenhouse, Newton NH. The quality of their plants and professionalism of their service makes them a great supplier to work with.

Danielle's Design provided fresh flowers in beautiful arrangements until the middle of September. She had her second child and decided to close her shop and become a full time mother. She will be sadly missed. After much research and help from Danielle, I found another great florist who has taken over our weekly orders. Board of Christian Education

Hello friends. Thank you for this opportunity to share with you all the happenings of 2015. The Board of Christian Education is responsible for the design, implementation, and supervision of the church's education programs for all ages. It has been a full year of weekly/monthly classes, special events, and community service projects. We have been building a roster of active church families and are seeking to reach all children and youth of preschool through high school age. We currently have about 30 families but the actual attendance to Sunday School, Youth Bible Study, and Youth Group is ever changing. Sundays go from 5-22 total kids depending on calendar. The Youth Group active member list of 16 also fluctuates each time they meet. We constantly seek to increase not only attendance but the personal meaning of our programs to all who attend. To that end, all traditional programs are being examined for effectiveness. We are also focusing on finding new and improved program offerings and investigating new ways to reach the community.

** DETAILS **

New this year – SUNDAY SCHOOL EVERY SUNDAY!! The Board of CE voted to offer Sunday School classes and Nursery on every Sunday of the year beginning with Homecoming and ending with the Annual Year End Celebration Picnic. The constancy that this schedule offers should help parents to know that their children/youth are always welcome here. We hope this gives busy families more opportunities to come in and share their faith.

New this year – TEEN LOUNGE – A portion of Memorial Hall was transformed into a youth friendly lounge atmosphere in the effort to make our youth more comfortable when attending Sunday School. All items used here were donated or came up from the Thrift Shop. At no expense, we were able to transform the area. The young people seem more at ease talking and hanging out here as they explore their faith.

SAFETY – While God keeps us safe, there is also a need to ensure the safety of all the children and volunteers of Sunday School. In the spring, The Board of CE, with the approval of Building/Grounds and The Trustees, passed new guidelines for the maintenance of the class areas and formulated guidelines for volunteers and parents regarding virus safety. The Board of CE in collaboration with The Safe Church Committee held a fire and safety drill in September.

NURSERY – Thank you to all of the teenagers and parents who staff the nursery weekly. A small group (Emma Formosi, Austin Spencer, Maddie Nelson, Jennie Nelson, Janine Heck) cover this program and we thank them all for their dedication. Attendance in the nursery is often just one or two children. We hope as GCC grows, more families will use this service.

CRADLE ROLL – This log follows the children of baptisms performed here at GCC. Cards are sent to these children on their birthdays and at Easter from baptism until they receive the age of 3.

SUNDAY SCHOOL COORDINATOR – Exciting news...after a long search...Kathy Pennie came on board in December as our Sunday School Coordinator. We thank her for all her efforts to date and look forward to her guidance in 2016. She brings a fresh energy, solid teaching background, and a genuine love of children to this position.

CURRICULUM – This was ordered directly from the UCC this year giving us a large savings in cost. The "All in One Bible Fun" program features easy to follow instructions for teachers and interactive activities and discussions for students. It's a win-win! The four main categories of topics are Favorite Bible Stories, Heroes of the Bible, Stories of Jesus, and Fruit of the Spirit which covers such topics as patience, kindness, generosity and faithfulness.

** WALKING WITH GOD **

CHILDRENS CHAPEL – On the first Sunday monthly, all children meet together for a special service that includes communion, prayers/scripture readings, and music. Thank you to the Deacon team and Caroline Cranos for being an integral part of these services.

EASTER SUNRISE SERVICE at Veasey Park was coordinated by Amy Szarek and our youth along with the help of the Deacons. It was well attended and continues to be a simple yet special service. Thank you all who assisted.

BLESSING OF THE ANIMALS – God gave us wonderful animals and we blessed them all. The new October event included special guests from the MSPCA, both human and animal. The children/youth participated in hands on exploration of the animals while being reminded that all animals of the earth need our love, justice and care. This day concluded with

a Blessing by Pastor Lance on the church lawn. Pets and people of a variety of ages showed up to participate. There were lots of smiles, tails wagging, and fellowship. It is hoped that this becomes an annual event.

STEWARDS OF THE CHURCH – The church children/youth took an active part in the Snowflake Fair. Sunday School children were able to put together animal treat bags to sell at the Fair. Thank you to all the parents and kids who donated time, bags, ribbon/tags, and fill items for this event. The children had a great time putting all these together and we saw many of them take a lead role in making this event happen. The Youth Group prepared and served the Friday Night meal at the Fair. All in all, there were many great contributions from our children and youth to benefit the church.

** GROWING IN FAITH **

ADULT BIBLE STUDY – This group was led by Pastor Lance in both the spring and fall. Group size was approximately 6-10 people. During this transition time in the church, the Board of CE will be looking for additional opportunities for adult education. Please feel free to contact us if you would like to lead a group.

YOUTH SUNDAY SERVICE – In May, the children had the opportunity to share their Sunday School experiences with the congregation as they led morning worship. Second grade students were presented with their bibles.

MACUCC WORKSHOP – Lisa Quinnan and Barbara McGovern attended the fall conference. There were many interesting workshops available. They attended How to Grow a Vibrant Sunday School Program, Youth Group Seeds and Mission Trips and came back to our meeting with some new ideas and renewed enthusiasm. It was a great opportunity and well worth the time it took to participate in this event. We will be working on integrating these ideas into the 2016 schedule.

SUNDAY EVENING CLASS - November brought a new offering of an evening Bible Class for kids grades 5 and up. Our preplanning included recruiting Chairpersons from the congregation to lead various areas; recruiting head chefs for each meal; securing donations and items that became our Prize drawings; finding new and also welcoming back veteran vendors; posting sign-ups for food donations and volunteer workers; sending out and posting advertising; coordinating room usage and layout; calendars and writing announcements with the church office. Perry Park Preschool Committee

The Perry Park Preschool Committee functions as a liaison between the preschool director and the Board of Trustees. The committee is responsible for making recommendations to the Trustees regarding the establishment of policies and procedure, approval of the annual budget, and preschool employee performance reviews and salary adjustments.

Financial: The preschool yearly finance report shows the preschool operated with a surplus on hand. Teacher bonuses were given at the end of 2014-2015 school year and at Christmas 2015. The budget for the 2015-2016 school year was completed by the director based on 39 students; it was presented to the Finance Committee and Board of Trustees in May 2015 and approved as presented. Profit from the Yankee Candle fundraiser was \$1171. The registration rates were kept the same, \$35 per child for returning students and \$50 per child for new students. To remain competitive for the 2016-2017 school year, the rates for all three program options will be increased. Additionally, a 5-day option will be offered for Pre-K students.

Summer School program tuition for 2015 remained the same at \$100 for 1 week and \$190 for 2 weeks.

Enrollment: The second half of the 2014-2015 school year maintained an enrollment of 35 students. September 2015 started the new school year with an enrollment of 40 students, which has remained constant throughout the first half of the year.

Events: The public Art Show in March was well attended. Several pieces of art created by the students were on display. A bake sale fundraiser was held in conjunction with the Art Show. Fifteen students and their families attended graduation in June. Another successful Summer Program was held during the weeks of July 13-17 and 27-31. Three teachers ran the program, which was attended by 13 students the first week and 12 students the second week. The themes of Nature and Camp PPP were very successful. In September students and their families attended an Ice Cream Social and Open House to visit the classroom and enjoy some dessert.

Buildings and Grounds Committee

The Building and Grounds functions as a subcommittee of the Board of Trustees and is responsible for the general building and maintenance of the church and parsonage. The members of the committee for this year were: Lou D'angelo as Chairperson, Dave Prescott Vice-chair, Emeritus, Barb Harrold as secretary, Mike McDermott, Robert Lay, Carroll Gustafson, Bill Forsyth - Emeritus, Gerry Tibbits - Emeritus, & Sextons (Carroll Gustafson & Barry Lay)

The approved budget for 2015 was \$12,500.00. No major projects were undertaken this year.

CHURCH MAINTENANCE items that were undertaken and completed:

SANCTUARY

Stained glass windows had some water pooling on sills, due to the heavy winter weather and variable temps. Sextons dried them and kept a close watch on them for rest of winter.

The boiler heat relay system/Thermostat for Sanctuary was adjusted & repaired.

Bloom on Pews: When the Sextons apply Teak Oil it makes the pews look good, but the bloom keeps reappearing. The Pews were probably installed/made in approximately 1995-96, Bloom appeared in the last 5 or 6 years. This is an ongoing project to eliminate the bloom.

Baptismal Font inspection: During set-up of VBS, the baptismal font was knocked over. It was Reset by Fire Department but needed assessment for safety. The assessment showed that the Baptismal Font is in 5 pieces/sections. The guiding pipes, which were damaged in the previous fall, were replaced and the Font sections were re set. Members of B & G, using a frame designed by Mark Szarek, were able to move the Font's sections and check its' parts.

Pew Skirts were completed and installed on Dec 19, 2015

Daniels Electric installed the remaining EMERGENCY lights.

Sexton painted pipes installed by Daniels Electric for electrical work done.

FELLOWSHIP HALL /MEMORIAL HALL

Roof Leaks from winter snow buildups in small Kitchen over window were fixed.

Office heat was off a couple of days. Sexton checked the batteries and adjusted the position of the unit to get it to function properly.

Closure on the entry doors was repaired

Basement Storage Area frame-in is in process

Office AC units were installed/removed seasonally, and Steeple fans cleaned/lubed for summer usage

FH Kitchen – sink and faucet issues resolved, plus re-wired the coffee urn, put together a unit for washing the silverware in DW, and designed and built spacer shelves for storage freezer

For the THRIFT SHOP a second new de-humidifier for the sorting-room/bathroom area was purchased & installed. Also we replaced the outdoor container for donations with a larger unit.

Sunday school rooms were cleaned, floors washed/vacuumed and painting done in preparation for beginning of SS in Sept. The SS room next to the Thrift shop had the ceiling painted and the carpet replaced.

Occupancy Inspection Of Church & Fellowship Hall

All inspections Passed and Inspection Certificates in place

Boiler Inspections were done & the church boilers passed 12/15 and fees are paid.

Sexton attended the boiler inspection with the State Inspector

FH Kitchen Health inspection noted Sink rim/counter connection needs repair. In Process.

GENERAL OUTDOOR MAINTENANCE ITEMS

Snow Removal was done well by our removal service during the big winter events of 2014-2015. Mike McDermott cleared the extra snow piles from parking lot in the Spring, using his tractor with front-end loader.

We purchased a small portable sander for the parking lot for the 2015-16 Winter.

National Grid replaced the gas meter which was damaged due the heavy snow pack 2014-15 winter.

FH/MH Gutters were cleaned to deal with/prevent overflows during rains. FH roof vent pipe was checked. It showed no leaks & looks good

Cleaned gutters and checked the chimneys over parlor. The areas over Ladies Parlor ceiling with leaks were repaired.

The Speed bumps were in place by May and were removed in Dec

The Sanctuary bulkhead doors were painted

Sealcoating of the parking lot & driveway was completed in July and the parking lines painted

Power-Washing of all the church buildings (Sanctuary and both FH & Mem Hall) was done in July.

The remaining plastic covering of the *Electrical "saddle':* was removed.

Grounds cleanup included trimming the bushes along the drive and front of church and office areas. Cut back more knotweed, removed more leaves from the parking lot, mulched and removed leaves from parsonage yard and removed and replaced the old tarp covering the metal ramp parts.

Parsonage & Sanctuary Bee issues were resolved by a hired exterminator.

PARSONAGE REPAIRS/CONCERNS that were managed and done or ongoing are:

For the *Exterior repairs*, a Repair man/handy-man group was hired to work on outside projects for any painting vs replacing for shutters, window trim, window-wells covers, basement bulkhead doors, front doors/porch, remove broken fence panel.

Parsonage winterization: (Pastor & family moved out in Oct)

Greg Stark was contacted to check the radiators for appropriate winterization, now that the parsonage is empty.

Parsonage is checked alternate days for any possible issues during winterization mode, and various lights are left on as security.

The parsonage front room is temporarily used as a storage & sorting space for the WVA mission project items.

The windows were assessed and a list made of those that need to be ordered for the next stage of this window replacement project.

FOR PERRY PARK PRESCHOOL, these items were done.

Hallway cleaning and touch up painting

Boards on the shed were repaired, painted & replaced as needed.

For 2015, the Church's portfolios (in cash, stocks and bonds) continue to be maintained by Cambridge Trust Company (CTC) and the United Church Foundation (UCF). For 2015, the Maddock Scholarship fund paid out a total of \$3000 for 6 scholarships.

Overall, the Church's portfolio was impacted by the decline in stocks precipitated by investor nerves. The recovery, while some consider it meek, continues.

While the Committee reminds the congregation that gains will continue to be modest in the foreseeable future, it remains committed to the current investment policy, as executed by CTC and UCF.

The Committee has completed its review of the long term year over year performance of both the CTC and UCF funds, and determined that CTC has been better stewards of GCC's investments.

Therefore, the Investment Committee and the Trustees have begun the process to authorize CTC to take over the investment of the funds managed by UCF.

The investment policy remains the same; only the choice of investment manager for those funds (which includes the Maddock fund) will change so that all funds will be managed by CTC.
